

ORDINANCE NO. 819

AN ORDINANCE OF PENN TOWNSHIP AMENDING ORDINANCE NO. 633 FIXING AND IMPOSING SEWER RENTS AND CHARGES, INCLUDING CONNECTION CHARGES AND SURCHARGES FOR INDUSTRIAL WASTE, FOR THE USE OF THE SEWERS AND SEWER SYSTEMS, WITHIN THE TOWNSHIP, PROVIDING FOR THE COLLECTION OF SEWER RENTS AND CHARGES AND IMPOSING PENALTIES FOR DELINQUENT PAYMENTS; AND AUTHORIZING OTHER NECESSARY ACTION.

**BE IT ENACTED AND ORDAINED**, by the Penn Township Board of Commissioners, York County, Pennsylvania, and it is hereby ordained by the authority of the same that Ordinance No. 633 shall be amended as follows:

**SECTION 1: AMENDMENTS:**

SECTION 1: DEFINITIONS

Shall be amended to read:

The definitions as set forth in Ordinance No. 683 and No. 704 are hereby incorporated into this Ordinance.

SECTION 4: SEWER RENT RATES

Subsections (1) and (2) under Section A Single Occupancy or Use, except Commercial and Industrial establishments, shall be amended to read:

- (1) Meter rates. For properties served with water by the water supplier, sewer rents based upon water consumed as determined by the quarterly reading of the water supplier as follows: for the quarter ending May 31, 2019, and for each quarter ending the last day of each February, May, August and November thereafter, the following rates shall be charged:

Quantity of Water Used (gallons per quarter)	Quarterly Rates
First 7,000 or less	\$55 minimum
All over 7,000	\$6 per 1,000 gallons

- (2) Flat rates. For properties not served with water by the water supplier, a flat quarterly sewer rent of ninety-one dollars (**\$91**) per quarter for the quarter ending May 31, 2019, and for each quarter ending the last day of February, May, August and November thereafter will be charged.

Subsection D shall be amended to read:

- D. Garbage grinders. The charge for each garbage grinder shall be nine (\$9) per quarter for the quarter ending May 31, 2019, and for each quarter thereafter.

**SECTION 2: SEVERABILITY**

The provisions of this ordinance are severable. If any provision of this ordinance or its application to any person or circumstance is held invalid, said invalidity shall not affect any other provision or application of this ordinance, which can be given effect without the invalid provision or application of the ordinance.

**SECTION 3: REPEALER**

All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 4: AMENDMENT TO TOWNSHIP CODE**

The Articles hereby adopted shall be deemed to be incorporated into the Penn Township Code so that reference to the code shall be understood and intended to include such changes.
